Food Bridge Program - Britepaths coordinates a weekly food program by finding and matching a group of volunteers to a list of
clients referred by government agencies. The volunteers typically pay for groceries and/or gift cards and deliver them directly to the
clients. In addition, Britepaths maintains a food pantry in order to make emergency deliveries to families with urgent needs.
During 2016, approximately 16 volunteer organizations participated in the program and assistance
was provided to 1,030 individuals.

Seasonal Programs - Britepaths works with Fairfax County government agencies, community based organizations, faith communities,
area businesses, individual families, and other volunteers to provide school supplies and holiday meals, gifts of clothing and toys,
and store gift cards to clients referred by government agencies, faith communities, and not-for-profit organizations. Britepaths
served 13,941 individuals in 2016.

Community Education Program - Britepaths raised community awareness about the struggles of our clients through several activities.
1,080 people attended Britepaths' community awareness events. Britepaths staffed an information table at multiple community
fairs and workplaces and engaged hundreds of community members. Britepaths was featured in local news channels 22 times
about its activities and programs, all of which engage the community. Britepaths participated in Chamber of Commerce activities.
