IN FISCAL YEAR 2025, BRITEPATHS HAD THE OPPORTUNITY TO RUN A PILOT FOOD ASSISTANCE AND FINANCIAL EMPOWERMENT PROGRAM THROUGH A FAIRFAX CITY GRANT PROGRAM, CALLED BRITESTEPS. A COHORT OF 25 FAIRFAX CITY RESIDENTS WITH CHILDREN WERE SELECTED, AND EACH RECEIVED ONE GROCERY GIFT CARD PER MONTH UPON COMPLETION OF A FINANCIAL EMPOWERMENT OR WORKFORCE DEVELOPMENT ACTIVITY, FOR A DURATION OF 6 MONTHS.
